EXPENSE ORGANIZATION OVERVIEW

JUDICIAL NOMINATING COMMISSION

The duties and structure of the Judicial Nominating Commission are set forth in the Constitution and statutes. Article 5, Section 4 of the Constitution establishes the Commission. W.S. 5-1-102 and 5-5-111, describes the duties and the terms of the members, as well as specifically providing for the reimbursement of actual and necessary expenses of the members.

The Judicial Nominating Commission meets only when it becomes necessary to fill a vacancy in the positions of justices of the Supreme Court and judges of the district and circuit courts. Its objective is to submit three names to the Governor, who makes the final selection. The Commission has refined its procedure in order to (1) receive a show of interest by more lawyers, thus enlarging the group from which the three name submission may be made, and (2) secure a more comprehensive background on those who have shown such interest.

Consequences of Inadequate Funding:

The Nominating Commission will not be able to fulfill its constitutional and statutory requirement of filling judicial vacancies if it is not adequately funded.

The majority of the budget is for in-state travel of commission members. In addition, small amounts are requested for office supplies and communication costs.
