**ORDER REPEALING THE EXISTING ORDER REGARDING UNIFORM
CITATION FORM**

AND

**ORDER ADOPTING NEW UNIFORM CITATION FORM FOR USE IN
WYOMING COURTS OF LIMITED JURISDICTION**

This matter came before the Court upon its own motion. In anticipation of the statewide use of e-citations, which will allow for the electronic transmission of citation information to the circuit courts statewide, and which will likely involve many if not all law enforcement agencies, this Court finds that it should repeal the existing Order regarding Uniform Citation Form, signed November 25, 1986, and adopt a new Order on Uniform Citation Form, which accounts for the technological advances in the twenty-seven years since the previous order was signed. It is, therefore,

ORDERED that effective July 1, 2014, the existing Order adopting the form of the Uniform Citation for use in Wyoming Courts of Limited Jurisdiction, signed November 25, 1986, be and hereby is repealed; and it is further

ORDERED that a new Uniform Citation Form, attached hereto and incorporated herein, shall be, and hereby is adopted for use in all Wyoming courts of limited jurisdiction; and it is further

ORDERED that (except for a reasonable time to utilize existing forms) no other form of citation may be used as a charging document in any Wyoming court of limited jurisdiction; that there shall be only one charge per citation; that all citations filed with all Wyoming courts of limited jurisdiction shall be in uniform numerical sequence; that the

original citation and all copies thereof shall be legible for use by the courts and by the state agencies having administrative duties and responsibilities with respect to said citations; that the Bail Bond Committee shall review and recommend to the Supreme Court any and all changes to the Uniform Citation Form as well as any and all changes to the Wyoming eCitation Repository Gateway Requirements (which primarily follows the NCIC data codes), attached hereto and incorporated herein; that any eCitation shall look substantially like the Uniform Citation Form, and any superficial differences shall be approved by the Bail Bond Committee; that it be duly noted that the Wyoming Highway Patrol has consented to continue to serve as the central supplier of the uniform citation forms, and has established a billing process for such purpose; and it is further

ORDERED that if a citation, written under Title 31, Motor Vehicles, Wyoming Statutes Annotated, is not paid in full within ten years of issuance, the court may order the case be dismissed and the file destroyed. This does not apply to those citations written for Wyo. Stat. Ann. § 31-5-233, driving under the influence; and it is further

ORDERED that this order and the attachments be published in the advance sheets of the Pacific Reporter and that this order and the attachments be made available online at the Wyoming Judicial Branch's website, <http://www.courts.state.wy.us>. The order and its attachments shall thereafter be spread at length upon the journal of this Court.

NOTICE TO VIOLATORS-READ CAREFULLY

There are several violations of law which require appearance before a judge. When you have been charged with one of those offenses, or when the arresting officer has reasonable cause to believe that you will disregard your promise to appear in court, the arresting officer will take you to the proper judge without delay.

Wyoming is a member of the Nonresident Violator Compact. If you reside in Wyoming or a member state and fail to post bond or appear in court for a violation of a traffic offense, your driver's license may be suspended.

DISPOSITION PROCEDURE

If the box labeled "MUST APPEAR" is checked on this citation, you are required to present yourself to the designated court on the date and time indicated. If the box labeled "may forfeit bond in lieu of appearance" is checked, this case may be disposed of in one of the following ways:

- (1) Appear before the court as promised and plead "not guilty" which entitles you to: (a) a trial at a future date to be set by the court, (b) an attorney, or a court appointed attorney under certain conditions, and (c) a bond hearing on that date if your trial date is set over to another date. At the trial the burden of proof is upon the prosecution to prove the charge beyond a reasonable doubt.
- (2) Appear before the court and plead "guilty" or "nolo contendere" (no contest) and pay the fine and costs as assessed by the judge and/or serve a possible jail sentence. You will be given an opportunity to explain the facts and extenuating circumstances.
- (3) Except for offenses requiring your personal appearance, you may avoid court appearance if you deposit bond and costs fixed by the Wyoming Supreme Court or Municipal Court for the offense for which you are charged. You may post this bond with the officer that has issued this citation (if authorized by law), with the court, or by mail. If you wish to pay by mail, please do so by money order or cashier's check (NO CASH). The payment must be for the exact amount and must be received before the court date. Please write the citation number on the payment and mail it with this copy of the citation to the designated court.

NOTICE

Failure to comply with one of the above procedures may result in the issuance of an arrest warrant for you with the possible additional charges of failure to appear.

If you do not sign the below Waiver and Forfeiture, the bond you have posted will be automatically forfeited if you do not appear in court. Bond forfeiture will be treated the same as a conviction by driver's licensing authorities.

WAIVER AND FORFEITURE

I, the undersigned, do hereby knowingly waive my right, (a) to appear before a judge, (b) to an attorney, (c) to a trial, and do hereby voluntarily forfeit bond to the offense charged in the citation, understanding that when I sign below, I do not have to appear before a judge and the case is then disposed of.



1 Introduction

This design document is intended for a technical audience concerning the Supreme Court electronic citation (e-citation) submission gateway. In this context, gateway is technically defined as a web-service, or a secure tool set that enables the exchange of data over the Internet.

Specifications in this design document are intended to be the electronic “baseline” for e-citation data filed into circuit courts. This may be updated to reflect current changes.

Advantages of using a web service for the e-citation gateway include:

- **Platform independence** – Any entity wanting to exchange data with the gateway can use the development integration technology that they are most comfortable with.
- **Security** – Access to the web service is by exception only. This includes only authorized machines being able to interact with it. Communications with the e-citation gateway is SSL-encrypted to enable Internet submission.
- **Ease of Integration** – Communicating with a web service is within technical reach of most software organizations. For example, your application would construct a SOAP request message, send it to the gateway via HTTPS and wait for a SOAP response.

The e-citation submission process populates the Citation Repository which is a repository for all e-citations generated in Wyoming. There is no interface to facilitate the retrieval, updating, or removal of citation data once it has been submitted to the gateway at this time.

This document defines the citation data to be sent to the repository, the electronically generated format of the e-citation that is presented to the defendant and the format of the e-citation that is presented to the courts. If an agency generates a citation to give to the defendant, it must match the defendant copy noted in Appendix L. If when the e-citation is submitted to the repository it does not have a PDF version of the Court copy the repository will generate one that matches the court copy noted in Appendix M.

2 Participation, Questions, and Contact

Submission of e-citation data to the gateway is a secure process. This begins with an authorized justice entity representative contacting the Supreme Court for electronic authorization and credentials. The process of being authorized is described below:

1. Visit the <http://citationgateway.courts.state.wy.us> web site for up to date documentation concerning the usage and participation with the gateway.

2. Using the form on the above website, please submit a notice of interest to use the gateway. Examples of information required includes: participating entity name, entity contact information, outgoing IP address of submitting entity that will be used to test submission with a testing-gateway.
3. The Supreme Court will then respond with further documentation required to create an interface for communicating with the gateway. This includes how to access the Web Service Definition Language, the test site address, your entityID and password.
4. Create your application to submit e-citation data.
5. Using the test-gateway, test your application until all development has occurred with the submission application process.
6. Upon successful e-citation submission, further coordination with Supreme Court staff will be necessary for local court scheduling, training and deployment of electronic citations.

3 Web Service Design Specifications

There is one method for submission of electronic citation data to the gateway, InsertCitations. The data passed to this web service method is contained in several data objects.

The gateway standardizes data while it also remains flexible in letting an entity choose the terminology it wishes to print on a citation. To that end any value on a citation that could be derived from a multiple choice option such as a “drop down box” or “check box” will have a standardized code but the description can be whatever is used by the submitting entity; wherever possible NCIC codes will be the standard to assign to a description.

For example hair color as described in [Appendix D](#) uses the NCIC code of BLN to mean Blond or Strawberry. On the citation given to the defendant, the software printing the citation might print BLND or blond or STWBRY. In the data record sent to the eCitation repository the code BLN should be sent with the description printed on the citation given to the defendant. In this way the citation as it was given to the defendant can be recreated from the repository and data reporting will have a uniform value to use to identify terms and values.

Web Service Method

InsertCitations

This method is used to send citations to be inserted into the eCitation repository database. The Response object returned will contain a message of the overall success of the request. It also contains a list of the citations that were in error and what the error is.

4 Wyoming Statutes

When submitting eCitations that are written against a Wyoming statute; the statute number must match a statute number in the list of statutes maintained by Wyoming Supreme Court. The list of statutes can be obtained by contacting the Wyoming Supreme Court IT department. You will also need to provide a point of contact to receive statute updates.

5 Trooper/Officer list

Any agency submitting eCitations that are bound for Wyoming Circuit courts must provide a list of active officers and their badge numbers to the Wyoming Supreme Court IT. The list must be in an Excel format and contain the following fields in this exact order:

Last Name, First Name, Middle Name, Badge Number, Agency ORI#

Anytime a change has occurred to this list it must be re-submitted to the Wyoming Supreme Court IT department.



Appendix A

eCitation Number specifications:

Currently all citation numbers in Wyoming are unique because there is one controlling entity that prints and distributes the citation booklets. The citation number that gets submitted to the eCitation repository must be unique across all the law enforcement agencies in Wyoming as well, but because each law enforcement agency can have their own electronic system creating numbers electronically there is no way to have one controlling entity giving out citation numbers. To this end a new citation number format has been created that will give each agency the ability to keep track of their own citations numbers. The format of the number is the three digit entity ID number that is used to identify an entity to the eCitation repository and is assigned by the Wyoming Supreme Court, a six digit incremental number, followed by a two digit alpha incremental suffix.



If entity 001 is submitting citations to the repository then it will have 999999 citations that it can create before it increments the alpha numeric double digit to AB and then can start the numbering back at 000001. For example, when the number gets to 999999 it can increment 999999AB to 000001AC and so on until ZZ. This gives each agency the ability to create 675,999,324 citations before they need to roll over and start with 000001 AA again.

Appendix F

Wyoming Drivers License Class Types: For driver's licenses issued in the state of Wyoming the following reference table applies:

Class "A" Vehicle: Any <i>combination</i> of vehicles with a gross combination weight rating (GCWR) of 26,001 pounds or more, provided the GVWR of the vehicle or vehicles being towed, including the combined weight rating of 2 trailers, is in excess of 10,000 pounds. May operate off-road recreational vehicles and mopeds.
Class "B" Vehicle: Any <i>single</i> vehicle with a GVWR of 26,001 pounds or more and/or towing a single vehicle or trailer that has a GVWR of 10,000 pounds or less. May operate off-road recreational vehicles and mopeds.
Class "C" Vehicle: Any single vehicle, except motorcycles, with a GVWR less than 26,001 pounds OR any vehicle, except motorcycles, with a GVWR less than 26,001 pounds towing a vehicle/trailer with a GVWR of 10,000 pounds or less. May operate off-road recreational vehicles and mopeds.
Class "M" Motorcycle: May operate motorcycles or a 3-wheel trike. Class "M" may be combined with any of the Class "A", "B", or "C" licenses. May operate off-road recreational vehicles and mopeds.
Class "I": Indicates license is an "instruction permit".
Restricted Class "RC," "RC-M" or "RM": May operate a non-commercial Class "C" and/or "M" vehicle within the following restrictions: (1) Valid only between the hours of 5 a.m. and 8 p.m., (2) within a 50-mile radius of their domicile, and (3) only at the direction of their parent or guardian.
Class "I2": May operate a non-commercial Class "C" and/or exempt commercial Class "B" vehicle within the following restrictions: (1) May drive only between the hours of 5 a.m. and 11 p.m., (2) cannot transport more than 1 passenger under the age of 18 years who is not an immediate family member, and (3) the licensee must ensure that all occupants in the vehicle are wearing seat belts.

SUMMONS

NOTICE TO VIOLATORS-READ CAREFULLY

There are several violations of law which require appearance before a judge. When you have been charged with one of those offenses, or when the arresting officer has reasonable cause to believe that you will disregard your promise to appear in court, the arresting officer will take you to the proper judge without delay.

Wyoming is a member of the Nonresident Violator Compact. If you reside in Wyoming or a member state and fail to post bond or appear in court for a violation of a traffic offense, your driver's license may be suspended.

DISPOSITION PROCEDURE

If the box labeled "MUST APPEAR" is checked on this citation, you are required to present yourself to the designated court on the date and time indicated. If the box labeled "may forfeit bond in lieu of appearance" is checked, this case may be disposed of in one of the following ways:

- (1) Appear before the court as promised and plead "not guilty" which entitles you to: (a) a trial at a future date to be set by the court, (b) an attorney, or a court appointed attorney under certain conditions, and (c) a bond hearing on that date if your trial date is set over to another date. At the trial the burden of proof is upon the prosecution to prove the charge beyond a reasonable doubt.
- (2) Appear before the court and plead "guilty" or "nolo contendere" (no contest) and pay the fine and costs as assessed by the judge and/or serve a possible jail sentence. You will be given an opportunity to explain the facts and extenuating circumstances.
- (3) Except for offenses requiring your personal appearance, you may avoid court appearance if you deposit bond and costs fixed by the Wyoming Supreme Court or Municipal Court for the offense for which you are charged. You may post this bond with the officer that has issued this citation (if authorized by law), with the court, or by mail. If you wish to pay by mail, please do so by money order or cashier's check (NO CASH). The payment must be for the exact amount and must be received before the court date. Please write the citation number on the payment and mail it with this copy of the citation to the designated court.

NOTICE

Failure to comply with one of the above procedures may result in the issuance of an arrest warrant for you with the possible additional charges of failure to appear.

If you do not sign the below Waiver and Forfeiture, the bond you have posted will be automatically forfeited if you do not appear in court. Bond forfeiture will be treated the same as a conviction by driver's licensing authorities.
